




Best practice CQRs

Complete, high quality clinical quality registry (CQR) data capture at a health system level is best achieved when data collection fits within existing reporting structures and is facilitated by national digital hosting capability.

This includes **contemporary database technology and quality assurance processes** (as evidenced in the United Kingdom National Health Service and Sweden, Denmark and the Netherlands)

Successful national CQRs have organisational governance arrangements; receive some government funding and are coordinated between national, state and territory governments and stakeholder groups.





Purpose of the revision

Maximise the use of health data to report on safety and quality in healthcare for the benefit of patients, consumers, clinicians, health service organisations, the health system and governments.

Support well designed national CQRs operating under national arrangements move towards achieving national reporting and the return of health information to the community Update guidance on clinical quality registry requirements' specification, infrastructure and technical standards; logical system architecture and design, and security compliance guidelines

Provide additional guidance on governance arrangements for CQR organisations, and reporting requirements and outlier management







Streamlining CQR Site Approval Pilot (SCrAP) 2021-2022

Key activities of Stage 1 of the project included:

- 1. Providing an overview of the processes and costs associated with the current site Research Governance Office approval processes for CQRs
- Reviewing existing authorising and data transfer mechanisms/models for CQRs to obtain data from hospitals/practitioners with Australia and internationally
- 3. Considering the appropriateness of these identified mechanisms/models to be adapted for nationally prioritised CQRs in Australia.
- 4. Determining the enabling structures and processes needed to support alternative authorisation/data transfer model(s).
- 5. Making recommendations to the National CQR Strategy regarding implementation of alternative models in Australia.

Streamlining CQR Site Approval Pilot (SCrAP) 2021-2022

Key activities of Stage 2 of the project to undertake the pilot alternative model included:

- 1. Development of project governance;
- 2. Identification of pilot CQRs and sites (health services) for potential matching;
- 3. Matching of pilot CQRs to pilot sites;
- 4. Review of pilot CQR and site-related policies and procedures and related documents;
- 5. Co-design of a 'generic CQR health service' streamlined approach including identification and development of key supporting documents and processes;
- 6. Testing of the streamlined approach with the pilot CQRs and sites;
- 7. Development of evaluation criteria from stakeholder interviews and surveys, and
- 8. Evaluation of the pilot
